Parish Council meetings

Nine meetings of the Parish Council took place in 2016 - 7. Attendance by the public averaged 19 residents, peaking at 24. Meetings were also attended by the two District and County Councillors, the Police Community Support Officer and his Beat Manager. Councillors have been professionally supported throughout the year by part-time Parish Clerk, Zöe Godden. Issues raised in public open session and taken up by the Parish Council included broadband coverage and speed, a broken stile and gate, dog fouling, drains, footpaths, overgrown foliage, parking, signs, speeding, traditional finger post restoration and an unadopted road.

Annual Parish Meeting

The Annual Parish Meeting took place on Sunday 7 May, attended by 41 people.

Angela Kerr, Chief Executive Officer of the Citizens Advice South Somerset (recipient of a Parish Council grant) outlined the services that are provided and the changing need to which they respond. Newly elected district councillor, Hayward Burt, was introduced. Table based discussions took place on topics for the further implementation of the Community Plan. Policies considered included additional facilities for sport, young children and teenagers; potential need for allotments, small workshops and offices and a design guide.



Charlton Horethorne Community Plan

The Parish Council approved 26 policies to form the Community Plan in July 2016.



This had been produced in just ten months by a working group of nine residents (of whom three were parish councillors), supported by a South Somerset District Council grant and officer. 60% of the questionnaires were completed,

a high rate of return, and almost as many housing needs surveys. Both the Community Plan and the findings from the housing needs survey inform the work of the Parish Council.

Planning

The Lead Member for planning and the Chair routinely consulted applicants and neighbours about planning applications. Feedback was sent to SSDC's Area East Committee. Two briefings by agents for potential developers were attended by parish councillors regarding possible sites. Feedback was given at Parish Council meetings. Both agents have been briefed about the Community Plan policies and encouraged to hold public meetings, ideally before a planning application is made.

Affordable homes

A public meeting on 12 March gave overwhelming support to the idea of a Community Land Trust to build affordable homes. The first steering group meeting took place on 27 April.

Street scene

Parish Councillors held two sessions to tidy up the street scene, cleaning signs and clearing trouble spots. Grit boxes have been cleaned and filled. We arranged for SSDC to collect Christmas trees from the village for shredding.

Consultation

The Parish Council responded to consultations on rural housing, on the historic environment and on hate crime. Parish Councillors took part in training on planning and the community infrastructure levy and attended regional and county meetings for local councils.

Road safety

County Highways have helped with road safety, including Speed Indicator Devices and road narrows signs. Work is underway to extend the 30 mph zone. Support was given to Stowell residents to install a viewing mirror on the Mount Lane junction. Community Speed Watch was formed with the support of the police. Trained volunteers hold regular speed watch sessions.
